To apply for free and reduced price meals complete only one application for your household using the instructions below. Sign the application and return the application to any School Nurse's Office or the Food Service Department.

If you have a foster child in your household, you may include them on your application. A separate application is no longer needed. Call the school if you need help: 845-256-4050. Ensure that all information is provided. Failure to do so may result in denial of benefits for your child or unnecessary delay in approving your application.

PART 1 ALL HOUSEHOLDS MUST COMPLETE STUDENT INFORMATION. DO NOT FILL OUT MORE THAN ONE APPLICATION FOR YOUR HOUSEHOLD.

- (1) Print the names of the children, including foster children, for whom you are applying on one application.
- (2) List their grade and school.
- (3) Check the box to indicate a foster child living in your household, or if you believe any child meets the description for homeless, migrant, runaway (a school staff will confirm this eligibility).

Use of Information Statement: The Richard B. Russell National School Lunch Act requires the information on this application.
