Report out to BOE:

In accordance with our Initial Charge and Immediate Priorities as laid out in our NPCSD BOE documentation (linked above), we would like to raise the following targeted questions with respect to our District operation under the COVID-19 pandemic, to highlight our concerns of far reaching adverse impacts regarding educational attainment for all our students, but especially for our most marginalized, at-risk and vulnerable students even after schooling returns to a fully in-person set up.

As students return to school buildings in a hybrid in-person and remote set up, we are concerned about the following items:

- 1. How will students who don't want to (and or can't) wear masks be handled?
- 2. How will mask related referrals be coded in the discipline systems? Will there be a district-wide discussion/policy, or will it be handled on a building by building basis and how will these policies be communicated to teachers, students and parents?
- 3. How will students who are not actively participating in lessons being assessed?
- 4. How are ENL, Special Education, and at risk or other vulnerable student populations being supported?
- 5. Is the district gathering data to better understand how teaching and learning under covid is disproportionately impacting our most vulnerable students? In particular...
 - a. *This year:* How will learning assessment be tracked for students and how will the data be analyzed to understand patterns of inequity with respect to who has fallen behind during this school year?

b. *Planning for the future:* How will the school district work to catch students up who have fallen behind through the course of the school year?
