2015-2016 Tax Levy

Tax Levy Limit = 2.96%

Includes 1% Capital Project Increase



2.96% is NOT Individual Tax Rates

Revenue Issues for 2015-2016

GAP Elimination Adjustment (GEA)

- Restoration based on district "wealth"
- NPCSD GEA was over \$1.3M
- Statewide restoration of GEA is 66%
- NPCSD GEA restoration is 38% (\$496,000)
- State is withholding over \$800,000 in State Aid

Foundation Aid

- Statewide aid increase
 33% of GEA
- NPCSD aid increase is less than 0.4%, or \$32,000
- Total projected State Aid for 2015–2016 of \$13.4M is \$0.9M LESS than total State Aid in 2008–2009 (\$14.3M)

Balance


2.96% Tax Levy Limit

- 2014-2015
 Appropriated Fund Balance was \$1.7M
- Used to preserve educational programs
- 2015-2016
 Appropriated Fund Balance is \$1.0M
- \$700,000 of Reductions needed to make up shortfall

- Tax Levy Limit of 2.96% incudes the 1% increase for Capital Project
- 1% for Capital Project can *only* be used for debt payments
- If the debt payments are reduced, tax levy limit reduced by corresponding amount


STATE AID for New Paltz C.S.D. still below 2008–2009 levels

HISTORY OF NPCSD STATE AID



New Paltz C.S.D. lost over <u>\$11M</u> to GEA (2009–2016) including a loss of over <u>\$800K in 2015–2016</u> despite the State no longer having a deficit!

- Decrease of 1.0 Elementary Librarian
- Decrease of 2.4 Secondary Teachers (MS/HS)
- Increase of 1.0 Psychologist and 0.8 ESL Teacher
- Decrease of 0.5 Director of Technology
- Limit P-TECH Placements to Existing Level (1 student)
- Eliminate BOCES Alternative Education Placements
- Elimination of several "dead-end" runs of less than one mile for secondary students

CAPITAL

- Eliminate O&M vehicle
- Reduce repair budget by \$30,000
- Decrease due to buses removed from budget, additional \$480K would be added pending voter approval
