11.2 Request for Approval of Resolution in Support of Senate Bill S7378 and Assembly Bill A10363

WHEREAS: New York State enacted the Foundation Aid Formula in 2007 for the purposes of providing a sound, basic education to all students, and creating equity in school funding; and

WHEREAS: the New Paltz Central School District relies on Foundation Aid funding to meet the educational needs of our students, and ease the property tax burden on local taxpayers; and

WHEREAS: According to a 2019 report by <u>Alliance for Quality Education of New York</u>, the Foundation Aid Formula has not been used to calculate aid for school districts since 2011, and has instead been replaced with temporary aid formulas in the state budget, resulting in New York schools being underfunded by approximately \$4 billion; and

WHEREAS: New Paltz Central School District is owed more than 2.4 million dollars in foundation aid; and

WHEREAS: NYS <u>Senate Bill S7378</u>, and its companion <u>NY State Assembly Bill A10363</u>, propose to extend the top state income tax rate with the goal of fully funding Foundation Aid;

THEREFORE BE IT RESOLVED that the Board of Education of the New Paltz Central School District calls upon the New York State Legislature and Governor Andrew Cuomo to enact Senate Bill \$7378 and Assembly Bill A10363; and **BE IT FURTHER RESOLVED** that the Board of Education of the New Paltz Central School District calls upon the Governor and State Legislature to commit to fully funding Foundation Aid, including restoring \$4 billion in withheld aid to New York school districts.
