SPOTLIGHT ON PROGRAM - HIGH SCHOOL - Alexandra Nneji, Participation in Government Report

Principal Barbara Clinton introduced Alexandra Nneji and student Lucas Dempsey. Ms. Nneji stated this project was collaboration between the school and CREEO at SUNY New Paltz with Ms. Tobin Flusser and Gerry Benjamin. Ms. Nneji stated there was a grant issued to develop methods for children to get in touch with their local government.

The Board requested copies of any responses the group may receive from local agencies. Ms. Tobin Flusser noted she was impressed at the creativity and ability of the students to tackle the issues. Maria C. Rice noted that the information they received would be responded to by the Board.

Ms. Tobin Flusser reiterated that school counsel was contacted, and no actionable items exist, according to the school attorney, that would qualify as standing to remove the President of the Board from his position.

EXTERNAL AUDIT REPORT - Andrew J. Arias, CPA - Cooper, Niemann & Co. (15 minutes)

Mr. Kerr made motion to move the External Audit Report up the agenda. Motion seconded by Mr. Torres. All were in favor with none opposed. Motion carried 6-0.

Andrew J. Arias, CPA, from Cooper Niemann & Co. presented the trustees with a presentation regarding the external audit. Revenue Allocation was provided. Mr. Arias spoke of Expenditure Allocations, Fund Balances, and other balances such as school lunch fund, reserved for debt funds, and capital reserves. Mr. Arias noted that the general fund balance increased \$783,000. This money was used to set up an unemployment reserve and an additional \$500,000 was designated in 2011 budget for a total designation of \$1.8 million. Mr. Arias noted that the district's fund balance is within the 4% limitation, and he noted this is a sound place for the district to be in.

Mr. Arias noted there was extensive single audit work required and all ARRA programs were classified as "high risk". There were no significant deficiencies noted.

Mr. Arias spoke to the Board regarding GASB 45 and the Retiree Health insurance. This represents the present liability that the district has for retirees and current employees. Mr. Aria noted there were not written comments as a result of the audit, and there were minor issues discussed verbally with the Audit Committee. Mr. Arias noted that a clean unqualified opinion was received. Mr. Arias wanted to inform the Board that in the future there will be five different classifications of fund balance.

Mr. Arias noted the district has a strong Business Office. He commented that the staff is quite knowledgeable and they help to make his job easier. He thanked the staff for all of their assistance.

# STUDENT REPRESENTATIVE REPORT – Lucas Dempsey& - Julie Apuzzo

Julie Apuzzo, a New Paltz High School senior, appeared for an update for the Board. She informed the Board that student schedules were available early in the summer, and this gave students ample time to contact advisors and avoid potential issues. She stated this helped in a smooth transition with students and their schedules. Ms. Apuzzo stated there is a new Glee Class that is being offered to students this fall, and it is going well. Ms. Apuzzo stated that MPZ is the morning radio show for the high school, and it was up and running on the first day. Ms. Apuzzo stated the week before school started Peer Leadership had a Freshman Orientation, which went really well. Ms. Apuzzo noted that there were many students late last year, so this year something new was implemented. The first 10 minutes of school students are still considered, but students no longer have to go through the attendance office if they are tardy within the 10-minute time frame. They can go directly to their first period, and this avoids a delay in time getting to class. Student Government implemented this.

Lucas Dempsey noted this Friday is Constitution Day, and students have been interviewed on the constitution and their rights. Mr. Dempsey stated ID Cards were handed out to students for safety reasons. Mr. Dempsey stated students have to have an ID Card to access the school. Maria C. Rice stated this is for a single point of entry.

# SUPERINTENDENT'S REPORTS & DISCUSSION ITEMS

SUPT REPORT

### SUPERINTENDENT COMMENTS

Maria C. Rice noted Suzanne Worth is a Physical Education teacher in Lenape. She decided to coordinate participation in Denim Day, which this year will fall on October 8, 2010. This is a yearly event, and Superintendent Rice stated over \$1,400 was donated last year. Superintendent Rice stated over 211 people have taken part in the event, and over time \$16,000 has been donated to Cancer Research. She commended those involved and publically thanked Suzanne Worth for her fundraising efforts.

# DISTRIBUTION OF THE 2009-2010 STATE OF THE DISTRICT REPORT

At the next Board meeting members will be going through this with a presentation from the leadership team.

### **BUILDING ACTION PLANS – Principals**

Barbara Clinton, Principal of the High School came to present information on the Action Plan for the High School. Mrs. Clinton noted that their needs statement is a work in progress, and every year they make improvements and make their smart goals better so the public and the student know the expectations.

Mrs. Clinton noted that success is going to be determined by measured by a 10% growth in learning. Mrs. Clinton stated 100% of the students will be involved in authentic assessment activities. Mrs. Clinton noted that 100% of the educational staff will be involved in using technology as a role in learning.

Dr. Wiesenthal presented his plan next. He stated all schools have similar smart goals. Dr. Wiesenthal noted that the middle school has been focusing on 21<sup>st</sup> century learning. Dr. Wiesenthal noted that in lieu of final exams they gave authentic assessments, and this had amazing results. Mr. Wiesenthal stated one goal is to collect baseline data on the authentic assessment with strengths and weaknesses. Another goal is peer review of teachers. Dr. Wiesenthal stated they will be looking at the ELA assessments and breakdown of broad scores and item analysis, and designing assessments at the grade level. Dr. Wiesenthal noted the BLT will be reconvened, and more study groups will be continued. Dr. Wiesenthal noted the PRIDE survey will be given in October, and the data will be analyzed.

Debra Hogencamp and Michelle Martoni gave a joint presentation on action plans for Duzine and Lenape. Ms. Hogencamp stated that teachers will have peers to confer with during their prep time to improve efforts. Ms. Hogencamp stated that data analysis is important and they are looking into a more periodic review of the collected data. Measureable goals will be set, and the data will drive instruction throughout the year. Ms. Martoni noted that the common planning time is moving into a

learning community. Ms. Martoni noted that they had data received by Ms. Banner and they are working on analyzing the data.

President Kerr stated cohesive and inclusive culture is being created with the efforts of the administrators. He commended the teachers and the superintendent and the Board for their collaborative efforts. Mr. Greenfield echoed those comments and noted that much of what they have heard speaks volumes to what the administration accomplishes.

Maria C. Rice stated that the administration provides exemplary support to live up to the educational standards.

# ENROLLMENT UPDATE - Superintendent Rice

Mrs. Rice noted this year is unique because there has been a large influx of new students. Mrs. Rice noted the class sizes are a little larger than hoped, but still within the ranges that were set. The Superintendent stated 31 students exited 95 students were added. Superintendent Rice stated that Pre-K is 15 with max 16. The first grade range is between 19-21, the second grade range is 18-21, the third 19-21, fourth is 20-22, and fifth is 18-22. The Superintendent stated currently the district has 2320 students.

Maria C. Rice noted that there is a big influx regarding students coming in from private schools.

# TAX LEVY & THE TAX BILL – Assistant Superintendent Linden

Mr. Linden noted that the tax levy is the total amount the school district will collect in taxes. This year it was a 2.95% increase. Through equalization and assessments tax bills can vary. Mr. Linden noted that values of properties are going down. Mr. Linden stated the total value of properties went down \$15 million dollars. Due to fluctuations, six out of seven towns in the district decreased. New Paltz was the one town that increased.

Mr. Linden stated overall the tax levy was 2.95%, but New Paltz's share of the tax levy went up on average 4.64%. Gardiner's levy was up, but all of the other towns decreased in their tax levy. Mr. Linden stated there was a reassessment in the Town of New Paltz this year. Mr. Linden stated about 1/3 properties decreased, 1/3 stayed about the same, and 1/3 increased.

School tax levy rate per thousand was higher than the 2.95%. Mr. Linden stated that distribution between the towns is based on the portion of the entire district. Discussion ensued.

All in favor with none opposed. Motion carried 6-0.

Mr. Kerr noted that there was a request by the BOE President to individual members to submit their goals. One trustee responded, and all of his items were placed on the comeback list. Mr. Kerr requested if anyone else has any individual goals please hand them in and they will be dealt with according to input received. Mr. Kerr noted that he would like a comeback list into every board packet.

# CROSSING GUARD UPDATE - KT Tobin Flusser

Ms. Tobin Flusser went to the Village Board meeting last week regarding a Crossing guard for Manheim and Main St. Ms. Tobin Flusser noted the Village immediately decided to fund the position, and they placed an ad in the paper. It is in Village Law that they are required to place someone at the intersection, and they are doing same based on the need.

# SOUTH PUTT CORNERS ROAD UPDATE – KT Tobin Flusser

Ms. Tobin Flusser stated that the people of New Paltz asked the County to move this project up their priority list. Originally it was scheduled to commence work in 2014. The community reacted, including the Board of Education, and County Executor Michael Hein placed this back on the project list for work to commence as a priority. In 2011 it will be in planning and development, and the County stepped up and the possible finish date is 2014.

Mr. Greenfield thanked Bill Weinstein advising the community and assisting in the efforts to get this project as a priority. Mr. Greenfield stated Mr. Weinstein was in the forefront of this project and performed a great deal of the work.

In response to a public comment, Maria C. Rice will contact CSArch to see if their building survey assessed noise as in the cafeteria and gymnasium.

There was discussion on Policy 1510, the Policy on Public Comment.

Mr. Kerr noted there was a press conference by Michael Hein, County Executive to remove tobacco advertising any place where children can view it. This is a county-wide initiative, but a press conference took placed at Lenape School.

COMMITTEE CHARGE FOR INPUT COMMITTEES & FACILITIES ADVISORY COMMITTEE – Steve Greenfield Mr. Greenfield stated the Facilities Committee held a special meeting yesterday to discuss the comprehensive facilities planning. Mr. Greenfield noted there is a hand out with information and they are recommending the full Board review and support the contents. The information dealt with stakeholder groups, a larger facility committee, and gave them guiding questions to follow.

Discussion ensued regarding the two-meeting rule and the urgency of this information. Maria C. Rice noted that there are two meetings occurring within the next two weeks. The schedule is approved and the consultants are following the schedule, and it was based upon consultation and advice from CSArch after much discussion. CSArch presented much of this material already outlined. A Motion was made by Mr. Greenfield and seconded by Mr. Rich to accept the Community Committee Charges. Mr. Kerr requested that the press release be sent to Channel 23 e-mail address bulletin board.

KT Tobin Flusser requested the press release be sent to her at SUNY New Paltz, and also to all BOE Members. Any press releases regarding this project will be sent to the BOE. Ms. Tobin Flusser also requested the Scope of work from RFP be sent to her as well.

All were in favor with none opposed. Motion carried 6-0.

## NYSSBA RESOLUTIONS

Ms. Tobin Flusser noted that she has reservations on numbers 4, 5, and 6. Regarding the resolutions not recommended, Ms. Tobin Flusser supports #12. Ms. Tobin Flusser stated there are not a lot of opportunities for structural change, and a constitutional convention could provide a venue to discuss property tax for K-12 education. Mr. Greenfield noted the ones that are potential examinable there isn't enough content to make an objections.

Mr. Kerr noted that the Board is generally comfortable with resolutions and recommendations that encompassed the packet. It was the Board's consensus to allow Mr. Rausch to vote with NYSSBA's recommendations.
