REGENTS PROPOSAL ON STATE AID TO SCHOOL DISTRICTS FOR 2011-2012

Superintendent Rice introduced Martin Ruglis, the Ulster County BOCES District Superintendent. Mr. Ruglis gave a proposal to the Board of Education regarding Regents 2011-2012 Conceptual Proposal on State Aid to School Districts. Mr. Ruglis handed out a packet to the Board members for their review.

BUILDING CONDITIONS REPORT DISCUSSION FINALIZATION

Tom Ritzenthaler and Paige Lewis attended the meeting to answer questions of the Board and gave an update of their Building Conditions presentation. Mr. Ritzenthaler stated the Stakeholder Groups are ways to give a voice to the community. Their input is given to the Facilities Advisory Committee, who therein reports to the Board of Education. Discussion ensued.

OPERATING GUIDELINES – KT TOBIN FLUSSER – Deleted from agenda.

COST SAVING BRAINSTORM – WHAT TO RESEARCH?

Mr. Kerr asked for suggestions from Board Members regarding cost savings.

- Mr. Kerr made an inquiry about transportation schedules suggesting having larger buses shuttle students in and have smaller buses transport students to different locations if all schools operated on the same schedule. Mr. Kerr asked Superintendent Rice to have the Director of Transportation look into this.
- Mr. Kerr suggested a for-profit before and after school day care as a possibility to have on the school premises.
- Mr. Kerr asked if it would make sense for the district to hire a fulltime grant writer.
- Mr. Kerr suggested a contest be offered to the community for someone to come up with a viable revenue idea that would generate income on the land behind the football field.
- Mr. Kerr suggested the creation of an endowment or foundation. Mrs. Rice stated she is working on that already.
- Mr. Kerr would like to get an analysis of temporarily closing a school. Mrs. Rice stated it is called consolidation, and she and her staff are already working on that.
- Mr. Rausch said the Board should ask the staff to give suggestions in order to streamline ideas.
- Mr. Rausch asked about getting information on cost savings if transportation is contracted out.
- Mr. Rausch suggested contracting out to the same food service vendors that SUNY New Paltz uses to see if we can find cost savings there.
- Mr. Rausch suggested having college-type classes with instructors and teaching assistants where college students could be teaching assistants. Superintendent Rice stated there could be contractual issues with that idea.
- Ms. Tobin Flusser suggested having a consortium of services for food services.
- Ms. Tobin Flusser asked for Rick Linden to give her tax levy increases in all districts of Ulster County. She would like to know what the equivalent of a 1% tax levy increase for a median priced home in the district. Ms. Tobin Flusser also asked to obtain information of per \$1,000 per assessed value. Rick Linden said this is not available until August.
- Dr. Rodriguez noted we should examine the educational model by consolidating districts or working with other districts in several areas including transportation, academics, facilities, and examining combining the districts for cost saving measures.
- Dr. Rodriguez also suggested a local consortium with SUNY New Paltz and BOCES.
- Mr. Greenfield would like to reexamine the possibility of having two K-5 buildings.
- Mr. Greenfield suggested exploring potential savings of energy by changing the starting times of schools to later in the day.
- Mr. Greenfield also suggested if money could be saved by realigning classes between buildings, i.e., swapping grades between some of the buildings, for example if the middle school students moved to Lenape, and Lenape students moved to the middle school.
- Mr. Greenfield stated there is a great need for a water supply on South Putt Road, and the Town's most recent attempt to get water failed. Mr. Greenfield stated there is water on the district's land where the high school is, and it is worth exploring as an alternative revenue generator that the district research if it is an adequate site for producing water.
- Mr. Rich suggested offering smaller districts who are not able to offer AP Courses our services and have other districts participate financially in supporting AP Classes.
- Mr. Torres stated the close proximity of SUNY New Paltz should be utilized more. Mr. Torres inquired about classes that High School Seniors could take at SUNY for credit.
- Mr. Torres suggested on-line courses taught here and streamed through other districts.

Mr. Kerr noted he and Ms. Tobin Flusser would like to have a meeting with the VP of Finance at SUNY New Paltz, Superintendent Rice, and Rick Linden to see where cost savings and shared savings could be available to the district. Mr. Kerr stated if other members think of more ideas they should send them via email to the District Clerk.

Mr. Kerr asked if the suggestions above could be compiled into a list and discussed at the next meeting.

- Phasing out reliance on local property tax to provide a "sound basic education" state-wide in favor of a broader state-wide taxing system including income tax.
- To attract and retain regional education leaders, eliminate the salary and benefit cap on District Superintendents.
- Revision of the Contingency Budget Law to exclude increases in Special Education, energy expenses, and health costs for staff and retirees from the formula.
- Update and enhance the BOCES Aid Formula and encourage additional shared services.
- Wicks Law Reform
- Full funding of mandates.
- Legislation that provides full funding and supports legal reforms (including Triborough Amendment Reform) for the State's public schools to eliminate the need to fund Charter School initiatives.
- Reduce reporting requirements.

Discussion ensued. Dr. Rodriguez suggested imposing the two meeting rule. Members discussed several negative aspects of the resolution and decided the two-meeting rule was not necessary because they were against the resolution as presented. Mr. Kerr asked suggested a letter be sent to Ulster County School Boards Association regarding their disapproval of this process.

Zero members were in favor of the motion to approve agenda item 9.3, and seven members were opposed. Motion was defeated.
