SUPERINTENDENT COMMENTS

Mr. Kerr noted that the Town of New Paltz Summer Recreation Program will take place at Lenape school. Mr. Kerr stated the district is working in partnership with SUNY for a literary clinic next year at Lenape. Mr. Kerr stated that more information will follow as it is available. Mr. Kerr stated Board of Education candidates can pick up petitions at the District Office and packets are also available on the district's website. Mr. Kerr stated Beauty and the Beast was a fantastic program he and Superintendent Rice attended at the New Paltz Middle School. The program was terrific and kudos and congratulations were given to all involved. Mr. Kerr stated there was an article in the Daily Freeman recently but some of the information was not accurate. Mr. Kerr stated that Superintendent Rice was to provide information to the community regarding projections into the next 3 years and this information will be available in the budget presentation today.

SUPERINTENDENT REPORTS

2011-2012 THIRD BUDGET PRESENTATION - Richard Linden

Mr. Linden gave an updated power point presentation on the budget. Mr. Linden provided the Board and the public with new slides and updated information pursuant to requests. Discussion ensued.

Superintendent Rice was directed to fill the open Principal vacancy with an internal candidate and save the district money. Ms. Tobin Flusser wanted to know if contingencies could be put in the budget to allow for any potential money that may be

given to the district by the State. Mr. Linden said once we adopt our budget, no changes can be made. Mr. Linden stated it was possible to adopt a budget with an added monetary amount which the district could use if more aid does come in than expected.

Superintendent Rice was directed to provide the Board with an additional slide to the budget presentation that contains information on reserve funds available, and what are the itemized (by fund) implications of recent, current, and projected use of these reserves.

Superintendent Rice was asked to add an asterisk to the slide regarding staffing reductions by unit showing percentage changes. The asterisk should indicate when savings have been realized by shifting salaries from NPCSD to grants rather than elimination of staff. Example was 18% reduction in Administration salary dollars - there was not an 18% reduction in head count. That warrants an asterisk.

Ms. Tobin Flusser wanted to know who answers blog questions on the district's website.

200811 3280 1 of 2

Community Relations

SUBJECT: COMMUNITY USE OF SCHOOL FACILITIES, MATERIALS AND EQUIPMENT School Facilities

The Board of Education recognizes and affirms the primary purpose of school facilities is to provide and promote the education of the District's children. It shall be the policy of the Board to encourage the greatest possible use of school facilities for community-wide activities. This is meant to include use by recognized athletic, civic, social and fraternal and religious organizations in accordance with law. Groups wishing who wish to use the school facilities must secure written permission from the Superintendent must submit a district Facilities Use Form in order to receive approval by the New Paltz Central School District. Groups must and abide by the rules and regulations established for such use including restrictions on alcohol, tobacco and drug use. The Superintendent, at his/her discretion, may consult with the Board of Education.

Excepted from this policy is the Floyd A. Patterson Field Complex.

Materials and Equipment

Except when used in connection with or when rented under provisions of Education Law Section 414, school-owned materials or equipment may be used by members of the community or by District employees and/or students for school related purposes only. Private and/or personal use of school-owned materials and equipment is strictly prohibited.

The Board will permit school materials and equipment to be loaned to staff members when such use is related to their employment and loaned to students when the material and equipment is to be used in connection with their studies or extracurricular activities. Community members will be allowed to use school-owned materials and equipment only for educational purposes that relate to school operations.

Administrative regulations will be developed to assure the lender's responsibility for, and return of, all such materials and equipment. Users may be charged for damaged and/or unreturned equipment and materials.

Specific Requirements Relating to Boy Scouts and other Title 36 Patriotic Youth Groups

The Boy Scouts Act applies to any local educational agency (LEA) that has a designated open forum or limited public forum and that receives funds made available through the U.S. Department of Education (DOE). It applies to any group officially affiliated with the Boy Scouts of America or any other youth group designated in Title 36 of the United States Code as a patriotic society.

This statute provides for the following:

- a) No covered entity (elementary school, secondary school or LEA) shall deny equal access or a fair opportunity to meet, or discriminate against any group affiliated with the Boy Scouts of America or any other Title 36 patriotic youth group that requests to conduct a meeting within the covered entity's designated open forum or limited public forum.
 - A <u>designated open forum</u> exists when the school designates a time and place for one or more outside
 youth community groups to meet on school premises or in school facilities, including during the hours
 in which attendance at the school is compulsory, for reasons other than to provide the school's
 educational program.
 - 2. A <u>limited public forum</u> exists when the school allows one or more outside youth or community groups to meet on school premises or in school facilities before or after the hours during which attendance at the school is compulsory.
- b) No covered entity shall deny access or opportunity or discriminate for reasons including the membership or leadership criteria or oath of allegiance to God and country of the Boy Scouts of America or of the Title 36 patriotic youth group.
- c) Access to facilities and the ability to communicate using school-related means of communication must be provided to any group officially affiliated with the Boy Scouts of America or any other Title 36 patriotic youth group on terms that are no less favorable than the most favorable terms provided to other outside youth or community groups.

7 – Approved at 4-6-11 BOE Meeting

The statute applies regardless of the entity's authority to make decisions about the use of its own school facilities. However, no entity is required to sponsor any group officially affiliated with Boy Scouts or any other Title 36 patriotic youth group.

The obligation to comply with the Boy Scouts Act is not obviated or alleviated by any State of local law or other requirement.
