BE IT RESOLVED that the New Paltz Central School District Board of Education approve the nomination of Mr. Rausch to run for a two year term as a trustee to the Ulster County BOCES Board of Education effective July 1, 2011 through June 30, 2014 as an At Large candidate.

**NEW PALTZ CENTRAL SCHOOL DISTRICT ELECTION/BUDGET VOTE**

**Request for Approval to Accept the Results of the Election/Budget Vote Held on May 17, 2011**

Motion made by Mr. Greenfield and seconded by Mr. Torres to approve the following:

BE IT RESOLVED, that the Board of Education of the New Paltz Central School District accept the voting results of the election held on May 17, 2011 as follows:

***Proposition #1***

Shall the Board of Education of the New Paltz Central School District be authorized to expend \$50,260,000 which will be required for school district purposes for the year July 1, 2011 through June 30, 2012 (The Budget), and to levy the necessary tax therefor?

***Proposition #2***

Shall the Board of Education of the New Paltz Central School District, Ulster County, New York, be authorized to purchase one 65-passenger or larger school bus at a maximum estimated cost of \$110,000; and two 20-passenger or smaller school buses at a cost of \$50,000 each, for a maximum estimated cost of \$100,000; for an aggregate maximum estimated cost of \$210,000; and that the sum of \$210,000, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and, in anticipation of such tax, obligations of the District shall be issued.
