VECHICLE PROPOSITION

Maureen Ryan gave a presentation to the Board regarding the need for acquisition of vehicles. The original resolution which has been voted on by the Board to place on the ballot has a total cost of \$490,000 for the purchase of vehicles. Ms. Ryan gave a bottom line recommendation as a revised scenario and presented the information to the Board. This second scenario has a total vehicle purchase of \$339,000, which incorporates one 65-passenger bus at a cost of \$113,000, four 20-passenger or smaller school buses at a cost of \$47,500 each, and one 7-passenger or smaller vehicle at a cost of \$36,000. This is being offered as a way to reduce the original proposition and lower the tax impact on the voters. Discussion ensued.
