STUDENT REP

Abigail King is a senior at New Paltz High School. Ms. King stated the AP Environmental Science class took a trip to Minnewaska and the Freshman Night in a Day assembly is coming up. Ms. King stated the varsity football team is 4-1 this year, the varsity girls' soccer team is 6-1, and they are both hoping to make it to sectionals this year. Ms. King stated a lot of students have complaints about the new dietary constraints and selections for school lunches. The school salads have changed, and students don't feel the quality is the same. There are issues with putting cheese on items costing extra, and Ms. King stated a lot of students are talking about this and she was asked to bring this up at the meeting.

SUPERINTENDENT'S REPORTS & DISCUSSION ITEMS

SUPT REPORT

CROSSING GUARD – Mrs. Rice gave an update on the Crossing Guard near the middle school. The dilemma is a municipal component that school districts can only hire crossing guards if they are crossing on school property. If the crossing guard is crossing students on municipal properties, the municipality is responsible for paying the employee. Superintendent Rice stated the school district has put away the money to pay for the crossing guard, but the district cannot pay the employee directly. Superintendent Rice and Supervisor Zimet have spoken with the County Comptroller and the Chief of Police to try and come to a resolution. The County is researching it more carefully to try and straighten out the component in the law that states the district cannot pay the crossing guard, and they will be making a recommendation to the school district on how to proceed. Ulster County Civil Service has also been contacted, who said it was not a civil service law, but it is a municipal law. Mrs. Rice stated five different districts have also been contacted, all of which pay their crossing guards via the police department.

Superintendent Rice spoke briefly about the Safe Routes to School Grant and the fact that the district cannot possibly comply at this time due to the time restraints and the research and work that is necessary to submit the grant. Mrs. Rice stated the district was given five days to complete a project that the district couldn't possibly complete in such a short time. Discussion ensued. Ms. Quinn asked to have this put on a comeback list for a later date for discussion. Mr. Rausch stated this could be put on the comeback list.

The date for submissions for the RFP is October 23rd and the Board will then interview applicants with the goal of appointing a firm in November so they can continue on the facilities master plan.
