SUPERINTENDENT'S REPORTS & DISCUSSION ITEMS

SUPT REPORT

PARK POINT PROJECT

Superintendent Rice clarified that the district has neither come out in support nor not in support of the project. The District has been undergoing analysis of what impact there will be to the school district. Superintendent Rice stated the analysis has shown there will be no significant influx of students to the New Paltz Central School District. Mrs. Rice stated the Board Members have every intention to create their own document and statement as to the impact on the District. This statement will be presented to the UCIDA, and a member of the BOE could possibly present this information at the Town Board Hearing. Superintendent Rice stated the District continues to gather information and watch to see if there are any changes. Discussion ensued. It was a consensus of the Board Members to obtain the following two documents: PILOT Application and Letter the Town Board sent to the IDA.

DEPARTMENT OF TRANSPORTATION (DOT) UPDATE

Mrs. Rice stated training and obtaining a crossing guard is still underway. The District will pay for the crossing guard, but the Town and Police Department are in charge of soliciting that vacancy.

3 – Approved at the 8/7/13 BOE Meeting

Mrs. Rice stated the District sent a follow up letter to the original letter sent to DOT. The first letter the District sent asked to designate a school zone, which DOT stated they would not do. The second letter which was recently sent asked DOT if they would be willing to put flashing light signs near the school to draw attention to drivers. As of today there has been no response back from DOT.

Mr. Bagley stated that Mr. Linden was able to obtain information for Board Members. Lengthy discussion ensued. Ms. Quinn made a motion to hire a consultant to run the numbers and recreated Cost Savings Summary Slide, and to calculate the Net Present Value. Motion seconded by Mr. Cournoyer. There was a friendly amendment to cap the work at 5 hours. Mr. Cournoyer, Ms. Quinn, and Mr. Rogers voted for the motion. Mr. Bagley, Mr. Rausch, Ms. Tresco, did not vote. Voting was 3 to 3 therefore the motion did not pass. Members did ask that Rick Linden contact the State Education Department, however, to see if New Present Value was worth pursuing.

Rick contacted Luis Rodriguez of the Palumbo Group. This Construction manager would serve as an oversight on top of the architectural firm. Discussion ensued. Mr. Rausch made a motion to hire Palumbo as Construction Manager. Motion seconded by Mr. Bagley. Mr. Rausch and Mr. Bagley were in favor. Mr. Cournoyer, Ms. Tresco, Ms. Quinn and, Mr. Rogers were not in favor. Motion did not pass. The Superintendent was given a directive to have Rick send out an RFP for a construction management firm.
