In the interest of protecting the privacy rights of the professional educators while facilitating parental access, the District shall require reasonable verification of identity prior to releasing information to parents/legal guardians.

The Superintendent of Schools shall develop a parental notice and information access form that shall be exhibits to this policy and an integral part hereof. he parental notice shall be posted in conspicuous locations within the District and the notice and form shall be made available on the District website.

OTHER DISCUSSION

Mr. Rogers had a question regarding how much the District pays for diesel fuel. Discussion ensued. Mrs. Rice stated on June 5, 2013 the BOE passed a resolution with the following prices: "market differential prices of \$0.032 for Premium Diesel and \$0.15 for Kerosene". Mr. Rogers stated he wanted to know if the price Rick Linden used included delivery charges and market charges. Mr. Linden did not have that information readily available.

Motion made by Mr. Bagley and seconded by Mr. Rausch that the adjourn at 9:34 PM. Motion failed with Mr. Rausch and Mr. Bagley voting in favor, and Ms. Tresco, Mr. Profaci, Mr. Cournoyer, and Ms. Quinn voting against the motion. Members decided to continue the conversation regarding Mr. Rogers' request. Mr. Rogers would like the price per gallon of diesel fuel. The Board decided to provide Mr. Rogers with one bill from Hess for natural gas and one bill from Central Hudson on natural gas along with the price per gallon of diesel fuel.
