WHEREAS, the Board of Education has received a letter from Bruderhoff Communities, dated November 4, 2013, requesting that the Board of Education of the New Paltz Central School District consent to a boundary alteration that would move certain parcels of real property from the New Paltz Central School District to the Kingston City School District (as set forth in Exhibit A annexed hereto and made a part of this resolution); and

WHEREAS, the Board of Education has carefully considered the request and believes that the requested boundary alteration is in the best interests of the New Paltz Central School District and the educational interests of the children involved;

THEREFORE, BE IT RESOLVED, upon the recommendation of the Superintendent of Schools, Maria Rice, that the Board of Education hereby consents to the requested boundary alteration and moving the parcels of real property set forth in Exhibit A annexed hereto from the New Paltz Central School District to the Kingston City School District, subject to submission of an application for alteration of the boundaries of a city school district in accordance with Section 1525 of the Education Law and the issuance by the Commissioner of an order altering the boundaries of the school district.
