Owen King, New Paltz-Asked the board to please consider the restoration of the library media specialist position at the elementary level.

Matt Elkin, Teacher at Duzine Elementary-asked the board to please consider the restoration of the library media specialist position and foreign language instruction.

Following the budget presentation and public comment, the board entered into a discussion about areas of the proposed budget that could possibly be reduced. Members agreed to the following: reduce board budget code A1920-400 for annual dues to the New York State School Boards Association (NYSSBA) from \$10,000.00 to \$0.00, reduce board budget code A1010-435 for consultants from \$500.00 to \$0.00 and for board budget code A1010-430 for staff development to remain at the proposed amount of \$4,000.00.

Following discussion regarding the possible restoration of the library media specialist position and foreign language instruction, the majority of board members agreed that although they would prefer to be able to restore these areas in the proposed budget, their priority is to restore the fund balance as proposed in the budget presentation.
