Brian Cournoyer, Board of Education President

Board President, Brian Cournoyer opened the Community Forum with the following statement:

"Welcome. The board has for the last several months been carrying on a discussion about success and what it means for our students, our administrators, our teachers, our district. Over the course of that conversation, we realize that for our district success is identified by our Core Intelligence, our Mission Statement and our Guiding Principles, empowering our students to be citizens of the world, passionate about learning. We've determined that this model of success is one that we believe in, so we felt that we didn't need to reinvent the wheel. But, how are we doing? Our discussion has now turned to evaluating success for our district and our students. How do we evaluate it in ways that align with our philosophy, with a measure of success defined by more than a test grade or acceptance to college? What metrics can we use to gage success for all students, recognizing that every student is an individual? So the purpose of our forum tonight is to listen to your thoughts, and to use the input that we get from you in the community, to help us in this undertaking. So, welcome, again. We're going to have an open dialog."

Members of the Board of Education and Administrative Staff will address questions, comments and recommendations, or provide clarifications as needed or may be appropriate.



During the open dialog with members of the board and the Superintendent, ideas and comments were provided by community members, Sophia Skiles of Gardiner, Stephanie Bash of New Paltz, Kerri Zerlini of Gardiner, Arielle Chiger of New Paltz, Cathy Sanchez of New Paltz, Linda of New Paltz and Karen Edelman of Esopus. Board member Michael O'Donnell provided the following visual aid as part of this discussion to assist parents, educators and students in determining where they are and where they would like to be:



New Paltz High School Senior Jeremy Brownstein shared comments with the board that he likes the idea of surveying students once they leave and reaching out to more diverse voices is an important one. Jeremy shared that his experience has been a very positive one but that you have to talk to a lot of people so you hear everyone's opinion. He shared that he has plenty of friends who are frustrated about things like AP and guidance. He stated he personally had a great relationship with his guidance counselors and always felt like it was his choice as to what courses he wanted to take. Jeremy shared that he has lots of friends who felt they were pressured into AP but also feels that AP courses are really valuable for students who want to take them. He stated he knows students who felt that once you are in AP you're pretty much locked in. In one of his AP classes he shared that it took parents coming in to help students get out of the class because they just didn't want to be there anymore. Jeremy also shared that if students choose to stay in, he felt really well prepared by his teachers and felt really engaged about the class. He stated that for some students, being in Regents level courses is not enough but having the opportunity to be in an AP level course and being really challenged was really a great experience.

Board President Brian Cournoyer announced the conclusion of the Community Forum and the board and Superintendent thanked the members of the community for their contributions to this important discussion.
