New Paltz High School Senior, Darren Tsai remarked on the need for additional foreign language teachers other than Spanish, as well as assistance in navigating class schedules for foreign language speaking students. Assistant Superintendent Michelle Martoni shared that the regulations implemented by the state for ENL students hindered the district's ability to provide this type of assistance and recognized that it was not in the best interest of the students. She shared that moving forward, changes would be implemented to assist non-English speaking students to better navigate their schedules and classes during a transition period.

New Paltz High School Senior, Sarah Rubin asked how the changes to classes at the elementary level impact class sizes at the high school and that currently some classes are far too full. Superintendent Rice shared that the issue is currently being worked on by High School Principal, Barbara Clinton and also shared that class sizes at the high school level are largely impacted by the number of students who sign up for a specific course.

SUPERINTENDENT'S COMMENTS

Superintendent Maria Rice reported to the board that given recent news reports about lead contaminants in water, she requested testing of the water in all school buildings. The tests performed and report issued by Michael O'Rourke at Ulster BOCES revealed there were no issues with lead in any of the buildings' water supply. Superintendent Rice also shared with board members that a copy of the report would be provided by the District Clerk upon request of the board members. Board Vice-President Aimee Hemminger publically acknowledged and thanked Superintendent Rice for her proactive steps in having the water tested.

Board member Steven Greenfield asked if the board would please consider moving the Legislative Committee Report to this portion of the meeting as he needed to leave early, and the board agreed.

► LEGISLATIVE COMMITTEE-Steven Greenfield

Legislative Committee Chair, Steven Greenfield asked that the board consider approving item 11.1-Recommendation for Adoption of Legislation. Motion was made by Steven Greenfield and seconded by Alison Easton to approve item 11.1-Recommendation for Adoption of Legislation.

During board discussion, Mr. Greenfield indicated that the Recommendation for Adoption of Legislation be specifically linked to New York State Assembly Bill A9829 and copies forwarded to specific offices of the legislature. Mr. Greenfield said he would assist the District Clerk with this information.

11.1 Recommendation for Adoption of Legislation

The Board of Education of the New Paltz Central School District strongly supports the passage of the following pieces of legislation. It is our understanding that with the recent election of Assemblyman Todd Kaminsky to the State Senate, that the Assembly bills under his sponsorship will be introduced in the Senate, and the Assembly nomenclature on the bills is included here for reference purposes.

We consider these bills to be a good start towards repairing the damage done to education in New York State over the last few years, and preventing future harm stemming from punitive funding restrictions, as well as providing for alternative pathways to graduation.

<u>A09626</u> - Decouples teacher evaluations from student test results and directs the Board of Regents to establish a committee to research and develop a valid and reliable method for teacher evaluations. In so doing, it removes existing incentives to "teach to the test" and be unable to respond appropriately to students' creativity and developmental differences

<u>A09578</u> - Repeals State takeover of failing schools and puts the school reform process back in the hands of local educators, parents, and other district stakeholders who are in the best position to understand the specific needs of the school district.

<u>A09584</u> - Reduces testing by directing the Board of Regents to establish a committee to shorten the length of tests and find ways to increase their transparency. Additionally, any administered tests would be provided afterwards to students, parents and teachers so that they can be used to improve the manner in which teachers teach and students learn.

A09579 - Creates an alternate pathway to graduation by establishing a Career and Practical Education (CPE) pathway to a high school diploma, which would provide a valuable alternative for students who do not wish to take – or are unable to pass – the Regents exams. By teaching practical life skills and training students for a career, a CPE pathway will better prepare all New York students for their post-high school lives, and send them into the economy fully eligible for employment.

4 – Approved at the 5/18/16 BOE Meeting

<u>A09829</u> – Decouples eligibility for new state aid increases to district and union renegotiation of existing contractual APPR systems. The ever-changing requirements and complexity of the options have been prohibitive to success within the mandated time frames, and it is impossible for both parties to be sure a satisfactory outcome can be achieved when a Sword of Damocles of the size the existing law created – for the New Paltz Central School District the amount to be lost is \$1.9 million, with the figure for public education statewide in the hundreds of millions – is hanging over our heads. Also, since the model used by the State for the test score component is neither reliable nor valid, achieving any new evaluation system that requires incorporation of student test results is fundamentally flawed. Forcing districts to take action known to be harmful to students and professional evaluation validity in exchange for funding instruction is unacceptable.

We thank you for your attention to our recommendations on these bills, and hope all will be adopted, with your support, before the end of the current session.

The District and Questar III may be referred to collectively herein as the "Parties."

WHEREAS, Questar III retained D'Arcangelo & Co, LLP ("D'Arcangelo") to conduct an independent audit of the funds that Questar III has accrued for purposes of satisfying future liabilities for post-retirement and other post-employment benefits ("OPEB"); and

WHEREAS, D'Arcangelo issued an Agreed-Upon Procedures Report on July 21, 2014 (the "Report") which, among other things, confirmed the total balance of funds accrued by Questar III for OPEB purposes as of June 30, 2013 and, of that balance, amounts that could be returned to the component and non-component school districts who participated in the relevant programs conducted by Questar III ("Accrual Amount"); and

WHEREAS, the Questar III Board has adopted a plan by which the OPEB Accrual Amount will be returned to such component and non-component school districts (the "Plan"), utilizing the basis for return set forth in the Report, and

WHEREAS, the Plan has received approval from the State Education Department; and

WHEREAS, the Parties hereto wish to memorialize the terms by which the District will participate in the

NOW, THEREFORE, THE PARTIES HEREBY AGREED AS FOLLOWS:

1. Questar III will return to the District a total of \$1,026.43 (the "Payment Amount"), which by this Agreement shall be deemed to constitute the District's full and complete entitlement to its share of the OPEB Accrual Amount. The Payment Amount shall be returned over a period not to exceed five years as follows:

Plan:

The Payment Amount as set forth above shall be returned in the form of a credit against the amount that the District otherwise is required to contribute to Questar III for non-component district CoSer charges in each of the school years set forth in the Payment Schedule above. If the portion of the Payment Amount to be returned in any school year exceeds the amount that the District must otherwise remit to Questar III, the excess balance shall be added to the portion of the Payment Amount to be returned in the next subsequent school year pursuant to the above Payment Schedule. If any such excess balance remains after the final year of the Payment Schedule, the excess balance shall be credited against the District's required contribution to Questar III in the next subsequent school year, and any additional school years as may be necessary to fully return the Payment Amount to the District. In no case shall Questar III be required to return any portion of the Payment Amount in the form of a cash payment to the District, or in any other manner except as set forth herein.

- 2. The District hereby accepts the return of the Payment Amount, as set forth herein, as full and complete satisfaction of any claim or entitlement the District would otherwise have, by law, contract, equity or otherwise, to return of any portion of the Accrual Amount.
- 3. In consideration for the return of the Payment Amount as set forth herein, the District hereby releases and discharges Questar III from any and all obligations, claims or liabilities, of any nature, that relate to the Accrual Amount and/or Questar III's OPEB accruals up to the date of execution of this Agreement, and the District hereby agrees that it will not commence, maintain or cooperate with any action, proceeding or claim in law or equity, of any nature or in any forum, against Questar III in relation to the Accrual Amount and/or Questar III's OPEB accruals up to the date of execution of this Agreement, which shall include but not be limited to any action, proceeding or claim in law or equity, seeking to recover (a) any portion of the Accrual Amount beyond that which is set forth in this Agreement, or (b) any other payment or relief that relates in any way to the Accrual Amount and/or Questar III's OPEB accruals up to the date of execution of this Agreement.
- 4. The District agrees that presentation of this Agreement shall serve as the District's unqualified and irrevocable consent to discontinue with prejudice any action, proceeding or claim in law or equity, commenced or maintained by or on behalf of the District and/or its officers in violation of the terms of this Agreement.
- 5. The Parties affirm that this Agreement fully and completely sets forth the agreed upon resolution of any rights, entitlements or claims that the District may have in relation to the Accrual Amount, and that no other promises or agreements have been made or would be effective in relation to the Accrual Amount.

6. The District and Questar III hereby each respectively affirm that the execution of this Agreement has been authorized by action of its Board of Education.

WHEREAS, at the Annual School District Election and Vote on the Budget of the New Paltz Central School District, duly called, held and conducted on May 19, 2015, a majority of the duly qualified voters of said School District voting thereat approved a proposition authorizing the purchase of three 65-passenger or larger school buses at a cost of \$114,800 each, for a maximum estimated cost of \$344,400; two 20-passenger or smaller school buses at a cost of \$47,200 each, for a maximum estimated cost of \$94,400; and one 7-passenger suburban at a cost of \$41,200, for an aggregate maximum estimated cost of \$480,000; and providing for the levy of a tax therefor to be collected in annual installments, with obligations of said School District to be issued in anticipation thereof; and

WHEREAS, it is now desired to provide for the financing thereof and for other matters in connection therewith, in accordance with said proposition;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the New Paltz Central School District, Ulster County, New York, as follows:

<u>Section 1.</u> The purchase of Five (5) school buses and one (1) suburban vehicle for the use of the New Paltz Central School District, which is not an assessable improvement, is hereby authorized as follows:

Three (3) 65-passenger or larger buses, at a cost of \$114,800 each, for a maximum cost of \$344,000.00; Two (2) 20-passenger or smaller school buses at a cost of \$47,200 each, for a maximum cost of \$94,400; and One (1) 7-passenger or smaller vehicle at a maximum cost of \$41,200.

Section 2. The aggregate maximum estimated cost of the aforesaid specific purchase is \$480,000 and the plan for financing thereof is by the issuance of serial bonds of said School District in the amount of \$480,000.00, hereby authorized to be issued pursuant to the Local Finance Law and this resolution. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. Such obligations shall be payable from amounts which shall annually be levied on all the taxable real property in said School District, and the faith and credit of said New Paltz Central School District are hereby pledged for the payment of said obligations and the interest thereon.

Section 3. The bonds, described above, shall be of the denomination of \$480,000.00 and shall bear interest at such rate as may be necessary to sell the same, which rate shall be determined in the manner provided in Section 59.00 of the Local Finance Law. Principal and interest on the obligations shall be payable in lawful money of the United States of America, in Federal Funds, at a banking institution to be determined. Such bonds shall be executed in the name of the New Paltz Central School District by the President of its Board of Education, or the Vice-President in the President's absence, and the corporate seal shall be imprinted thereon and attested by the School District Clerk.

Section 4. It is hereby determined that the period of probable usefulness applicable to the aforesaid specific class of objects or purposes is five (5) years, pursuant to subdivision 29 of paragraph (a) of Section 11.00 of the Local Finance Law. The proposed maturity of the obligations authorized by this resolution will not be in excess of five (5) years.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of said notes, is hereby delegated to the President of the Board of Education, the Chief Fiscal Officer, or to the Vice-President of the Board of Education in the President's absence. Such bond anticipation note and any renewals shall bear interest and

shall be of such terms, form and contents, and shall be sold in such manner as may be prescribed by said President of the Board of Education, consistent with the provisions of the Local Finance Law. There are presently no outstanding obligations which have been issued in anticipation of the sale of such obligations.

Section 6. All other matters, except as provided herein, relating to such bonds shall be determined by the President of the Board of Education, including the power to designate such bonds as "qualified tax exempt obligations" pursuant to Section 265(b)(3) of the Internal Revenue Code of 1986, if at the time of such designation, such officer is able to certify that: (I) the School District is, and was as of October 23, 1985, a political subdivision of the State of New York; (ii) it is reasonably anticipated that (a) the amount of "qualified tax-exempt obligations", within the meaning of Section 265(b)(3) of the Code which will be issued by the School District during this calendar year shall not exceed \$10,000,000.00 and (b) the bonds do not constitute part of an issue, and are not part of a series of issues issued for a common purpose, exceeding \$3,000,000.00 in the aggregate; and (iii) the sum of principal amount of the bonds and the principal amount of any other obligations heretofore designated by the School District during the current fiscal year does not exceed \$10,000,000.00. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the President of the Board of Education shall determine.

<u>Section 7.</u> The validity of such obligations may be contested only if:

- (a) Such obligations are authorized for an object or purpose for which such School District is not authorized to expend money; or
- (b) The provisions of law which should be complied with as of the date of publication of this resolution or a summary thereof are not substantially complied with and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or
- (c) Such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 8.</u> This resolution, which takes effect immediately, or a summary thereof, shall be published in a newspaper having general circulation in said School District, together with a Notice of the School District Clerk, substantially in the form provided in Section 81.00 of the Local Finance Law.
