WHEREAS, the negotiating teams for the District and the New Paltz Bus Attendants and Bus Monitors reached an Agreement, calling for the creation of a five-year successor Collectively Negotiated Agreement to the one that expires on June 30, 2016;

THEREFORE, BE IT RESOLVED that the Board hereby ratifies the Agreement between the District and The New Paltz Bus Attendants and Bus Monitors Contract covering the period from July 1, 2016 through June 30, 2021, and authorizes the funding of those monies necessary to implement the provisions of the 2016-2021 Collectively Negotiated Agreement.

Board President Brian Cournoyer read the following Statement on NPUT Negotiations:

"The negotiations between the District and the New Paltz United Teachers regarding a new collective bargaining agreement have been going on for well over a year now and have involved numerous meetings, both formal and informal, as the parties have tried in good faith to reach an agreement that will affect terms and conditions of employment this school year, and for multiple years ahead. The inadequate State Aid that the District received for the 2015-16 school year and the implications of the low CPI driven tax levy increase formula for the 2016-17 school year have placed untenable constraints on the parties, complicating the pathway to settlement.

The teams have met with mutually agreed upon PERB Mediators and are engaged with a mutually agreed upon PERB Fact Finder, who will receive written submissions on the issues in dispute from the parties and render recommendations for settlement that should be presented for consideration prior to the end of this school year. We look forward to receiving the guidance from the Fact Finder and are hopeful that the recommendations will lead the parties to an agreement.

Our situation is a product of the economic policies of the New York State Legislature that have been unkind to local school districts, in disregard of the countless unfunded educational mandates, and that do not put the children of our State first.

The board took seriously the statements made by the union leadership regarding a sum of \$900K in a previous 2010-11 budget. We asked the Assistant Superintendent for Business, Richard Linden, to research the matter. He has done so and we are satisfied that the money was expended as stated. At the next board meeting we will have a presentation explaining how the money was expended, and that it was done properly."
