WHEREAS, it is imperative that there be an adequate water supply for the New Paltz community to ensure uninterrupted service of safe and affordable water to Village and Town users;

THEREFORE, BE IT RESOLVED, that the Board of Education of the New Paltz Central School District expresses its strong support of the efforts of the New Paltz Town and Village Boards in working collaboratively on behalf of the community with the New York City Department of Environmental Protection to ensure a safe and affordable water supply to Town and Village of New Paltz users.
