

Recommendation

- Beacons a.k.a. Blue Lights or Strobes
 - Outside each facility (including the Transportation Center)
 - Cafeterias
 - Gymnasiums
- Public Address (PA) System Upgrades
 - Upgrade to connect to phone system
 - Fix exterior PA systems
 - Duzine only: Install new PA system with exterior speakers and connects to phone system

- Beacons a.k.a Blue Lights or Strobes
 - Money encumbered for approximately 13 Beacons
 - If more are needed the additional will be incorporated into the Safety Acquisition Plan
- Public Address System
 - MS upgrades via the Capital Project
 - Need to bid (PLEASE NOTE: Any cost over \$35,000 needs to be bid)

Recommendation

- Surveillance Cameras
 - Interior
 - Exterior
 - All Facilities

- Surveillance Cameras
 - Contacted a vendor for pricing
 - Need to bid
 - Encumbered money to begin purchases
 - Partial pay via the SMART Bond
 - Part of Safety Acquisition Plan

Recommendation

- Window Glass Security Film (Bullet Resistant)
 - All entrance doors with glass panels in each of the four school buildings and Transportation Center
 - All interior classroom doors with glass panes, sidelights and windows, that allow you to see into the classroom in all four school buildings
 - BOE Request Cost out all first floor exterior windows and glass panels in the exterior doors for all five buildings

- Window Glass Security Film (Bullet Resistant)
 - Requested preliminary costs from two vendors
 - Approximately \$8-12 per square foot
 - Need to bid
 - Part of Safety Acquisition Plan

Recommendation

 Large Screen Monitors for Greeter Stations

- Radios that Connect to System and Town
 - Replace radios that are not compatible
 - Increase number to accommodate updated Safety Plan

- Large Screen Monitors for Greeter Stations
 - Being priced for possible purchase
 - Part of Safety Acquisition Plan
- Radios that Connect to System and Town
 - Received from Vendor
 - Preparing for Distribution

Recommendation

- Window Treatment (Film)
 - For areas where there is no window treatment in order to hinder or restrict visual access to the room (possible consideration is the Lenape Cafeteria)

- Window Treatment (Film)
 - Facilities need to be reviewed by District Facilities, Dr.
 O'Rourke and New Paltz Police to determine need and solution
 - Part of Safety Acquisition Plan

Recommendation

■ Visitor Entry System

- Provide an additional layer of security
- Increased efficiency

Exterior Doors

- Door contacts for all exterior doors
- Tied to the District's security System
- Purpose To know if a door is left open via a computer or phone

Status

■ Visitor Entry System

- Systems under review by BOE
- May be able to purchase via BOCES and receive Aid
- Part of Safety Acquisition Plan

Exterior Doors

- Getting quotes
- Need to bid
- Part of Safety Acquisition Plan

Recommendation

Lighting

- Front parking lot Duzine
- Rear of Lenape
- HS Walkway (specific location TBD)
- MS Walkway new Courtyard

Status

Lighting

- More indepth review is being conducted
- MS part of Capital Project
- Other Buildings Part of Safety Acquisition Plan

Contents to be determined by the Safety Sub-Committee of the Health Advisory Committee when they begin meeting in the fall

Other Recommendations in Process, or Completed

Recess Monitor Training

- Completed September 3, 2019
- Will repeat for those who were not in attendance
- Additional training being planned
- Elementary Principals created "zones" to deploy monitors in all areas of the playground

■ Lock Down Drills, "Prepare, not Scare" Strategies Presentation

- Presented to all District Staff by Chief Snyder on September 3, 2019
- Four mandatory drills to be implemented at different times of the day
- Discussion and possible recommendation regarding decentralizing Lock Down Drills (Essential Question: Who will have the ability to initiate a lock down?)

Other Recommendations in Planning Stage

- "Stop the Bleed" Workshop
 - Being planned for all Staff
 - Tourniquets to be included in all Go Bags
 - Clotting agents may also to be included in all Go Bags
