| September - October | <p>Unit 1: The Number System</p> <ul style="list-style-type: none"> • How do you interpret quotients of fractions? • How do you divide multi-digit numbers? • What is greatest common factor? • What are positive and negative numbers? • What is a rational number? • How is a number line used? • What is a coordinate plane? • What are quadrants? • What is an ordered pair? • What is the absolute value of rational numbers? • How do you interpret inequalities using a number line? • How do you write inequalities using a number line? • How do you write inequalities using a number line? • How is absolute value used to distinguish comparisons regarding order? • What is the difference between the absolute value of 2 coordinates? <p>-----</p> <ul style="list-style-type: none"> • Apply and extend previous understandings of multiplication and division to divide fractions by fractions. • Compute fluently with multi-digit numbers and find common factors and multiples. • Apply and extend previous understandings of numbers to the system of rational numbers. | <ul style="list-style-type: none"> • Interpret and compute quotients of fractions, and solve word problems involving division of fractions by fractions, e.g., by using visual fraction models and equations to represent the problem. <i>For example, create a story context for $(2/3) \div (3/4)$ and use a visual fraction model to show the quotient; use the relationship between multiplication and division to explain that $(2/3) \div (3/4) = 8/9$ because $3/4$ of $8/9$ is $2/3$. (In general, $(a/b) \div (c/d) = ad/bc$. How much chocolate will each person get if 3 people share $1/2$ lb. of chocolate equally? How many $3/4$-cup servings are in $2/3$ of a cup of yogurt? How wide is a rectangular strip of land with length $3/4$ miles and area $1/2$ square mi?</i> • Fluently divide multi-digit numbers using the standard algorithm, • Fluently add, subtract, multiply, and divide multi-digit decimals using the standard algorithm for each operation. • Find the greatest common factor of two whole numbers less than or equal to 100 and the least common multiple of two whole numbers less than or equal to 12. Use the distributive property to express a sum of two whole numbers 1-100 with a common factor as a multiple of a sum of two whole numbers with no common factor. <i>For example, express $36 + 8$ as $4(9+2)$. (Expectations for unit rates in this grade are limited to non-complex fractions.)</i> • Understand that positive and negative numbers are used together to describe quantities having opposite directions or values (e.g., temperature above/below zero, elevation above/below sea level, credits/debits, positive/negative electric charge); use positive and negative numbers to represent quantities in real-world contexts, explaining the meaning of 0 in each situation. | <ul style="list-style-type: none"> • Prep tasks • Skills checks • Observation • Quizzes • Summative assessment |

Extend number line diagrams and coordinate axes familiar from previous grades to represent points on the line and in the plane with negative number coordinates. <ul style="list-style-type: none"> ○ Recognize opposite on opposite sides of 0 on the number line; recognize that the opposite of the opposite of a number is the number itself, e.g., $-(-3) = 3$, and that 0 is its own opposite. ○ Understand signs of numbers in ordered pairs as indicating locations in quadrants of the coordinate plane; recognize that when two ordered pairs differ only by signs, the locations of the points are related by reflections across one or both axes. ○ Find and position integers and other rational numbers on a horizontal or vertical number line diagram; find and position pairs of integers and other rational numbers on a coordinate plane. • Understand ordering and absolute value of rational numbers. <ul style="list-style-type: none"> ○ Interpret statements of inequality as statements about the relative position of two numbers on a number line diagram. <i>For example, interpret $-3 > -7$ as a statement that -3 is located to the right of -7 on a number line oriented from left to right.</i> ○ Write, interpret, and explain statements of order for rational numbers in real-world contexts. <i>For example, write $-3^{\circ}\text{C} > -7^{\circ}\text{C}$ to express the fact that -3°C is warmer than -7°C.</i> ○ Understand the absolute value of a rational number as its distance from 0 on the number line; interpret absolute value as magnitude for a | |

Include use of coordinates and absolute value to find distances between points with the same first coordinate or the same second coordinate. | |
| November - January | <p><u>Unit 2: Ratios and Proportional Relationships</u></p> <ul style="list-style-type: none"> ● What is a ratio? ● What are equivalent ratios? ● How do you describe a ratio relationship between two quantities? ● What is a unit rate? ● How do you describe the concept of a unit rate in words? ● How do you use various tables to describe and compare rates and ratios when solving real-world mathematical problems? ● What is a percent? ● How do you find a percent of a quantity as a rate per 100? <p>-----</p> <ul style="list-style-type: none"> ● Understand ratio concepts and use ratio reasoning to solve problems. | <ul style="list-style-type: none"> ● Understand the concept of a ratio and use ratio language to describe a ratio relationship between two quantities. <i>For example, “The ratio of wings to beaks in the bird house at the zoo was 2:1, because for every 2 wings there was 1 beak.” “For every vote candidate A received, candidate C received nearly three votes.”</i> ● Understand the concept of a unit rate a/b associated with a ratio $a:b$ with $b \neq 0$, and use rate language in the context of a ratio relationship. <i>For example, “This recipe has a ratio of 3 cups of flour to 4 cups of sugar, so there is $\frac{3}{4}$ cup of flour for each cup of sugar.” “We paid \$75 for 15 hamburgers, which is a rate of \$5 per hamburger.”</i> ● Use ratio and rate reasoning to solve real-world and mathematical problems, e.g., by reasoning about tables of equivalent ratios, tape diagrams, double number line diagrams, or equations. | <ul style="list-style-type: none"> ● Prep tasks ● Skills checks ● Observation ● Quizzes ● Summative assessment |

Include expressions that arise from formulas used in real-world problems. Perform arithmetic operations, including those involving whole-number exponents, in the conventional order when there are no parentheses to specify a particular order (Order of Operations). <i>For example, use the formulas $V = s^3$ and $A = s^2$ to find the volume and surface area of a cube with sides of length $s = \frac{1}{2}$.</i> ● Apply the properties of operations to generate equivalent expressions. <i>For example, apply the distributive property to the expression $3(2+x)$ to produce the equivalent expression $6 + 3x$; apply the distributive property to the expression $24x + 18y$ to produce the equivalent expression $6(4x+3y)$; apply properties of operations to $y + y + y$ to produce the equivalent expression $3y$.</i> ● Identify when two expressions are equivalent (i.e., when the two expressions name the same number regardless of which value is substituted into them). <i>For example, the expressions $y + y + y$ and $3y$ are equivalent because they name the same number regardless of which number y stands for.</i> ● Understand solving an equation or inequality as a process of answering a question: which values from a specified set, if any, make the equation or inequality true? Use substitution to determine whether a given number in a specified set makes an equation or inequality true. ● Use variables to represent numbers and write expressions when solving a real-world or mathematical problem; understand that a variable can represent an unknown | |
